On January 11, 2018 at 1:24 am, Officer Carney was on routine patrol when he observed a 1997 Honda make a right turn from Normandy Road onto Glendale Road without signaling the turn. As Officer Carney attempted to close the gap between the patrol vehicle and the Honda, the Honda accelerated, making multiple turns without signaling at a high rate of speed. Officer Carney was able to initiate a motor vehicle stop of the Honda on Clover Hill Road. Officer Carney made contact with the driver, who was identified as Mr. Zoll. As Officer Carney spoke with Mr. Zoll he detected the odor of an alcoholic beverage, and Mr. Zoll appeared to be impaired. Mr. Zoll was asked to perform field sobriety tests, and was subsequently placed under arrest. Mr. Zoll was transported to police headquarters, where he submitted to chemical breath testing. Mr. Zoll was charged with DWI, Reckless Driving, and Failure to Signal. Mr. Zoll was released to a sober driver pending a court hearing.

On January 11, 2017 at 7:42 pm, Officer Carlson responded to Kennedy's Budd Lake Motel to attempt to locate Mr. Mastroeni, who was known to have an active no bail warrant for his arrest out of Sussex County. Officer Carlson was able to locate Mr. Mastroeni, and placed him under arrest. Mr. Mastroeni was transported to police headquarters, and was subsequently turned over to Sussex County Sheriff's Office on the warrant.

All parties listed above are innocent until proven guilty in a court of law.
