On September 17, 2017 at 12:46 am, Officer Galop was on routine patrol when he observed a 2005 Dodge traveling north on Rt. 206 fail to maintain its lane of travel on multiple occasions. Officer Galop initiated a motor vehicle stop of the Dodge in the area of Chestnut Way. Officer Galop made contact with the driver, who was identified as Mr. Bryan. As Officer Galop spoke with Mr. Bryan he detected the odor of an alcoholic beverage, and Mr. Bryan appeared to be impaired. Mr. Bryan was asked to exit his vehicle to perform field sobriety tests. Mr. Bryan was subsequently placed under arrest and transported to police headquarters, where he submitted to chemical breath testing. Mr. Bryan was charged with DWI, Reckless Driving, Consumption of an Alcoholic Beverage in a Motor Vehicle, Open Alcoholic Beverage Container in a Motor Vehicle, Failure to Maintain Lane, Failure to Signal Lane Change, Littering from a Motor Vehicle, Failure to Wear Seatbelt, Obstructed View, and Failure to Exhibit Insurance Card. Mr. Bryan was released to a sober driver pending a court hearing.

All parties listed above are innocent until proven guilty in a court of law.
